Additionally, the Society undertakes research and publication on topics of Jewish law. The Society's publications include reference works, research tools and in-depth studies. To date, almost forty titles have been published with several already translated to English.

As a result of these studies, the Knesset has adopted principles of Jewish law in its legislation, and the Israeli courts have based numerous decisions on Jewish sources.

We believe that the Society could do much more to enhance the influence of Jewish values on Jewish society if only it had the financial wherewithal to do so. The nation of Israel can thus reach spiritual heights rooted in the wealth of Jewish law and become "a light unto the nations".
